*The following orders were CONTINUED from our last meeting at the request of Councilor Hecht.*

**ORDER #CC2018-025** (*Councilor Hecht*) **ORDERED** that the Gloucester Code of Ordinances Ch. 22 "Traffic and Motor Vehicles" Sec. 22-270 "Parking prohibited at all times" be amended by **DELETING** "Prospect Street, northerly side from its intersection with Friend Street for a distance of 125 feet in a westerly direction Monday through Friday".

**FURTHER ORDERED** that the Gloucester Code of Ordinances Ch. 22 "Traffic and Motor Vehicles" Sec. 22-270 "Parking prohibited at all times" be amended by **ADDING** "Prospect Street, northerly side, from its intersection with Friend Street in a westerly direction to its intersection with Taylor Street".

**ORDER #2018-026** (*Councilor Hecht*) **ORDERED** that the Gloucester Code of Ordinances Ch. 22 "Traffic and Motor Vehicles" Sec. 22-270 "Parking prohibited at all times" be amended by **DELETING** "Prospect Street, westerly side, beginning at its intersection with Spring Street, in a northerly direction for a distance of 200 feet".

**FURTHER ORDERED** that the Gloucester Code of Ordinances Ch. 22 “Traffic and Motor Vehicles” Sec. 22-270 “Parking prohibited at all times” be amended by **ADDING** “Prospect Street, westerly side, beginning at its intersection with Spring Street, in a northerly direction for a distance of 175 feet”.

**ORDER #CC2018-027** (*Councilor Hecht*) **ORDERED** that the Gloucester Code of Ordinances Ch. 22 “Traffic and Motor Vehicles” Sec. 22-270 “Parking prohibited at all times” be amended by **ADDING** “Pleasant Street, westerly side, beginning at a point 130 feet from its intersection with Warren Street in a northerly direction for a distance of 25 feet”.

*Objective: Parking meter #24 would be removed in front of Pleasant Street #32.*

#### **NEW ORDERS**

**ORDER #CC2018-028** (*Councilor Memhard*) **ORDERED** that the Gloucester Code of Ordinances Ch. 22 “Traffic and Motor Vehicles” Sec. 22-269 “Stop intersections” be amended by **ADDING** “Traverse Street at its intersection with Haskell Street.”

**ORDER #CC2018-029** (*Councilor Holmgren*) **ORDERED** that the Ordinances & Administration Standing Committee request that the Traffic Commission review the matter of limiting the amount of time and locations that commercial box trucks are allowed to park on public streets, and make a written recommendation to the Ordinances & Administration Standing Committee on the findings of their review, including whether any traffic ordinance amendments to the Gloucester Code of Ordinances are recommended.
